OBJECTOR'S PETITION

INTRODUCTION

- 1.) Objector Marc Mazzuca ("Objector") is a legal resident of the United States, State of Illinois, County of Cook, City of Park Ridge, and resides within the boundaries of the 6th Ward in the City of Park Ridge. Objector's place of residence is 2600 Windsor Mall, Park Ridge, Illinois 60068. Objector is a duly qualified, legal and registered voter at this address.
- 2.) Objector's interest in filing this petition ("Petition") is that of a voter desirous of seeing that the laws governing the filing of nomination papers for a candidate for election to the office of Alderman – Ward 6 (also referred to as "Alderman – 6th Ward" or "6th Ward Alderman") in the City of Park Ridge, County of Cook, State of Illinois are properly complied with and that only qualified candidates appear on the ballot for said office.
- 3.) Objector currently serves as Alderman – Ward 6 in the City of Park Ridge, County of Cook, State of Illinois having been duly elected by the voters of the ward in the consolidated general election held on April 9, 2013.

OBJECTIONS

- 4.) Upon information and belief, Objector makes the following objections to the purported nomination papers ("Nomination Papers") filed with the office of the Park Ridge City Clerk on December 19, 2016 by Candidate Patrick DeStefano ("Candidate") for the office of 6th Ward Alderman in the City of Park Ridge, County of Cook, State of Illinois ("Office") to be voted for at the consolidated general election to be held on April 4, 2017 ("Election"). Objector states that the Candidate's Nomination Papers are insufficient in fact and law for the following reasons.
- 5.) Pursuant to State law, nomination papers for the Office to be voted for at the Election must contain the signatures of not fewer than 67 duly qualified, registered and legal voters of the 6th Ward in the City of Park Ridge, County of Cook, State of Illinois collected in the manner

prescribed by law. In addition, nomination papers must truthfully allege the qualifications of the candidate, be gathered and presented in the manner provided for in the Illinois Election Code, and otherwise executed in the form provided by law. The Nomination Papers at issue here purport to contain the signatures of 67 such voters, and further purport to have been gathered, presented and executed in the manner provided by the Illinois Election Code.

#### Petition Sheet Objections

6.) The Nomination Papers contain fewer than the required minimum number of validly collected signatures of duly qualified, registered and legal voters of the 6th Ward of the City of Park Ridge, County of Cook, State of Illinois, signed by such voters in their own proper person with proper addresses as set forth by the objections recorded in detail in the attached Exhibit A which is incorporated into and is part of the Objector's Petition. Specifically:

A.) Upon inspection of official Cook County Clerk voter records conducted on December 23, 2016, the Nomination Papers appear to contain petition sheets with the signatures of persons who are not registered voters, or who are not registered voters at the addresses shown opposite their respective signature, as set forth in Exhibit A attached hereto and incorporated herein, under the heading "A. SIGNER NOT REGISTERED At Address Shown" in violation of the Illinois Election Code.

B.) Upon inspection of official Cook County Clerk voter records conducted on December 23, 2016, the Nomination Papers appear to contain petition sheets with the names of persons who either did not sign the papers or did not sign the papers in their own proper persons, and such signatures are not genuine and are forgeries, as set forth in Exhibit A attached hereto and incorporated herein, under the heading "B. SIGNATURE NOT GENUINE (Includes PRINTED)" in violation of the Illinois Election Code.

C.) Upon inspection of official Cook County Clerk voter records conducted on December 23, 2016, the Nomination Papers contain petition sheets with the signatures of persons for whom the addresses given are either missing entirely, incorrect, incomplete or illegible, as set forth in Exhibit A attached hereto and incorporated herein, under the heading "D. Signer's ADDRESS MISSING, INCOMPLETE, OR MISSTATED" in violation of the Illinois Election Code.

7.) A copy of the petition sheets filed by the Candidate in his Nomination Papers is attached to and is incorporated into the Objector's Petition as Exhibit B.

#### Statement of Candidacy Objection

8.) The Nomination Papers do not contain a properly signed, dated, and notarized Statement of Candidacy document as required by the Illinois Election Code. The Candidate's Nomination Papers included a Form SBE P-1B Statement of Candidacy (Independent) document in which the year shown in the original notarization date had been altered by scratching out the original date and writing in another year value above the scratched-out date. However, the alteration to the

original notarization date was not initialed by either the Candidate or the Notary Public whose stamp appears on the document.

9.) A copy of the Form SBE P-1B Statement of Candidacy (Independent) document filed by the Candidate in his Nomination Papers is attached to and is incorporated into the Objector's Petition as Exhibit C.

WHEREFORE, the Objector respectfully prays that, upon examination of the Candidate's Nomination Papers and the official voter registration records pertinent to the matters described herein, this Honorable Board declare the Nomination Papers of Candidate Patrick DeStefano for the Office to be insufficient in fact and law, and that the Board further grant the following relief:

- A.) Invalidate all signatures from the Candidate's Nomination Papers where i) the signatures are from individuals who are not registered voters, or individuals who are not registered voters at the addresses shown opposite their respective signature; ii) the individuals did not sign the papers, or did not sign the papers in their own proper persons; and iii) the signatures are accompanied by address information that is incorrect, incomplete, illegible, or missing entirely.
- B.) Invalidate the Statement of Candidacy document in the Candidate's Nomination Papers on the grounds that the form filed by Candidate was altered and not properly signed, dated, and notarized to account for the alteration.
- C.) Find that Candidate has failed to meet the minimum requirements set forth by the laws of the State of Illinois applicable to all candidates seeking the Office, in that i) the Candidate's Nomination Papers contain the valid signatures of fewer than 67 duly qualified, registered and legal voters of the 6th Ward in the City of Park Ridge, County of Cook, State of Illinois collected in the manner prescribed by law; and ii) the Candidate's Nomination Papers do not contain a properly signed, dated, and notarized Statement of Candidacy document as required by the Illinois Election Code.
- D.) Having failed to meet the minimum requirements set forth by the laws of the State of Illinois applicable to all candidates seeking the Office, find that the Candidate is therefore ineligible to appear on the April 4, 2017 ballot for said Office.
- E.) Enter a decision that the name of Patrick DeStefano as a candidate for the for the office of Alderman – Ward 6 in the City of Park Ridge, County of Cook, State of Illinois SHALL NOT APPEAR AND SHALL BE NOT PRINTED on the official ballot for the consolidated general election to be held on April 4, 2017, and
- F.) Enter any other relief that the Board may deem appropriate under the circumstances.
