Background:

At the August 3, 2015 meeting, the City Council approved an Ordinance removing resident parking restrictions on Arthur, from the dead end west of Hamlin to Aldine. These revisions were brought about as part of the validation process requiring staff to distribute a survey to residents abutting a restricted area every ten years, at a minimum, to validate the continued need for and desire of the residents for parking restrictions. Staff sent two notices to this area and as the required 51% favorable response was not received, the process to revise the ordinance accordingly began.

In late August 2016 staff was contacted by residents regarding student parking in this area. Per Council Policy Statement #19, staff surveyed this area and found that it met the criteria for restricted parking. Staff then conducted a survey of residents that abut Arthur, Seminary west to the dead end at Hamlin, to restrict parking from 8 a.m. to 2 p.m., Monday thru Friday, except Saturdays, Sundays and Holidays, resident permits excepted.

Ten (10) surveys were sent out, with six (6) needed for a 51% majority. Six (6) residents sent in responses in favor of these restrictions, none were not in favor and four (4) were no response. A copy of the draft Ordinance is attached.

This item was presented as an Action Item at the Committee of the Whole on October 24, 2016, at which time the Committee approved the motion on a voice vote of 6/1, with Alderman Shubert being the nay vote.

ORDINANCE

**OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE
AMENDING ARTICLE 13, CHAPTER 13, SECTION 2
OF THE CITY OF PARK RIDGE MUNICIPAL CODE**

SECTION 1: BE IT ORDAINED, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 13, "Permit Parking," Section 2, "Parking Prohibited within certain hours; Resident permits excepted," Paragraph C, "Parking Prohibited Within Certain Hours Restricted Hours," is hereby amended by adding the following language:

Street	Side of Street	From - To	Restricted Hours, Sat, Sun, Holidays Excepted, Unless Otherwise Stated	Zone
Arthur	Both	Dead end west of Hamlin to Seminary	8 a.m. to 2 p.m.	Magenta

SECTION 2: The Director of Public Works is authorized and directed to remove any signs posted on said roadways setting forth said restrictions.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

SECTION 4: The City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
