Background:

It recently came to the City's attention that the street leading to a parking lot off of Northwest Highway at Delphia is completely a privately owned access road. This came about as part of a review of private property areas within the city. In the past it was assumed that this street was a partial city right-of-way. Property owners have been notified that the City can no longer maintain this area and that, effective immediately, maintenance would be the responsibility of the property owners. Maintenance in this area includes snow removal and street and sidewalk defects.

As such, the following ordinances need to be deleted from the Municipal Code to reflect this change:

- 13-13-2, Resident Permit Parking restrictions
- 13-14-2, Parking Prohibited During Snowfall restrictions

This item was presented as an Action Item at the Committee of the Whole on November 14, 2016, at which time the Committee approved the motion on a voice vote of 6/0.

Recommendation:

First reading of an Ordinance amending 13-13-2 and 13-14-2 of the Municipal Code, Parking Restrictions on Delphia, Northwest Highway to Vacated Rabe Court, on the November 21, 2016 Council agenda for first reading.

ORDINANCE

**OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE
AMENDING ARTICLE 13, CHAPTER 13, SECTION 2
AND CHAPTER 14, SECTION 2
OF THE CITY OF PARK RIDGE MUNICIPAL CODE**

SECTION 1: BE IT ORDAINED, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 13, "Permit Parking," Section 2, "Parking Prohibited within certain hours; Resident permits excepted," Paragraph C, "Parking Prohibited Within Certain Hours Restricted Hours," is hereby amended by deleting the following language:

Street	Side of Street	From - To	Restricted Hours, Sat, Sun, Holidays Excepted, Unless Otherwise Stated	Zone
Delphia	Both	N.W. Hwy to vacated Rabe	9 a.m. to 5 p.m.	Red

SECTION 2: BE IT ORDAINED, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 14, "Snow Parking," Section 2, "Parking Prohibited During Snowfall," is hereby amended by deleting the following language:

Street	Side of Street	From	To
Delphia	Northwest	Northwest Hwy	Vacated Rabe Court
Delphia	Southeast	Northwest Hwy	Vacated Rabe Court

SECTION 3: The Director of Public Works is authorized and directed to remove any signs posted on said roadways setting forth said restrictions.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

SECTION 5: The City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
