Background:

At the September 12, 2016 Committee meeting, Angie Karlson, the property owner of 26-28 South Fairview, requested that a Loading Zone be designated in front of their building. The Municipal Code allows for a 15-minute Loading Zone under Chapter 15, Limited Time Parking.

In the past, the City has been very conservative in designating such areas as businesses and parking patterns change over the years as well as they would take away longer term parking spaces. At the September 12 meeting, after discussion, consensus was reached to move forward with two 15-Minute Loading Zone spaces at this location.

While reviewing this Section of the Municipal Code, staff has found two areas to be obsolete and recommends deleting them at this time.

Gewalt Hamilton has stated that this proposed change will not impact the parking study that they are performing.

This item was presented as an Action Item at the Committee of the Whole on October 24, 2016, at which time the Committee approved the motion on a roll call vote of 5/2, with Aldermen Moran and Mazzuca being the nay votes. and at the City Council on November 9, 2016 on a roll call vote of 6/1 with Alderman Mazzuca being the nay vote.

**ORDINANCE**

**OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE  
AMENDING ARTICLE 13, CHAPTER 15, SECTION 1  
OF THE CITY OF PARK RIDGE MUNICIPAL CODE**

**SECTION 1: BE IT ORDAINED**, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 15, "Limited Time Parking Areas," Section 1, "Fifteen Minute Loading Zone," is hereby amended by adding the following language:

Street	Side of Street	From-To
Fairview	West	40-foot "15 Minute Parking Zone", from property line to property line of 26 and 28 South Fairview

**SECTION 2: BE IT ORDAINED**, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 15, "Limited Time Parking Areas," Section 1, "Fifteen Minute Loading Zone," is hereby amended by deleting the following language:

Street	Side of Street	From-To
Prospect	West	From a point 207' northeast of the Summit west curb to a point 278' northwest of the Summit west curb
Prospect	East	From a point 98' southwest of the southwest curb line of S. Northwest Hwy to a point 108' southwest of that southwest curb line

**SECTION 3: BE IT FURTHER ORDAINED**, that the Director of Public Works is authorized and directed to post suitable signs.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

**SECTION 5:** The City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
