Background:

For the January 9, 2017 Public Works Committee meeting, Alderman Mazzuca had asked that staff include in the discussion of hardship exceptions resident parking on Peterson, adjacent to the area where the street narrows, between South Greenwood and South Western. Resident(s) in this area are seeking the ability to obtain resident parking permits to allow them to park on the resident restricted section of Peterson. This has not been allowed in the past as they do not abut a restricted street, per 13-13-2 of the Municipal Code. Currently, this area of Peterson is No Parking on both sides, from 1411 Peterson to Western, per 13-11-1 of the Municipal Code.

City Attorney Simon has suggested amending the parking restriction on Peterson, as listed in 13-13-2 of the Municipal Code, to reflect permit parking restrictions on Peterson, from Greenwood to Western. This would then allow the resident in the narrower area of Peterson to qualify for a resident permit parking sticker if they so desired.

Peterson, from 1411 Peterson to Western, would remain a No Parking area, per 13-11-1 of the Municipal Code.

This item was presented as an Action Item at the Committee of the Whole on January 23, 2017, at which time the Committee approved the motion on a vote of 5/0.

ORDINANCE

**OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE
AMENDING ARTICLE 13, CHAPTER 13, SECTION 2
OF THE CITY OF PARK RIDGE MUNICIPAL CODE**

SECTION 1: BE IT ORDAINED, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 13, "Permit Parking," Section 2, "Parking Prohibited within certain hours; Resident permits excepted," Paragraph C, "Parking Prohibited Within Certain Hours Restricted Hours," is hereby amended by adding the following language:

Street	Side of Street	From - To	Restricted Hours, Sat, Sun, Holidays Excepted, Unless Otherwise Stated	Zone
Peterson	Both	Western to Greenwood	8 a.m. to 5 p.m.	Orange

SECTION 2: The Director of Public Works is authorized and directed to remove any signs posted on said roadways setting forth said restrictions.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

SECTION 4: The City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
