Background:

As after hour businesses continue to open in Uptown Park Ridge, the need for late day/evening parking has increased. Acting Mayor Maloney, Alderman Shubert and staff recommend that the Prairie Avenue Coin Box Lot, located at 15-23 South Prairie, be open to free parking for residents and non-residents after 4 p.m. This lot is currently used primarily for commuter parking and space opens up late in the day and in the evening. There are 58 parking spaces and 1 handicapped space (59 total) in this lot.

As this area and lot will be included in the Uptown Parking Study being done by Gewalt Hamilton, approved by the Council in September 2016, further recommendations may be forthcoming.

Gewalt Hamilton has stated that this proposed change will not impact the parking study that they are performing. A quick recount of the Prairie Coin Box Lot would need to be done from 4pm-8pm a couple weeks after the change is implemented

This item was presented as an Action Item at the Committee of the Whole on October 24, 2016, at which time the Committee approved the motion on a voice vote of 7/0.

ORDINANCE

**OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE
AMENDING ARTICLE 13, CHAPTER 16, SECTION 8
OF THE CITY OF PARK RIDGE MUNICIPAL CODE**

SECTION 1: BE IT ORDAINED, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 16, "Parking Meters and Metered Parking," Section 8, "Zones Designated," "Parking Lots, Prairie Avenue Lot Coin Box" is hereby amended to read as follows:

Parking Lots	No. of Spaces	Time Limit Hours	Hours of Operation
Prairie Avenue Lot Coin Box	58	12	7 am to 7 pm, except Sat, Sun & holidays, <u>free after 4 pm</u>

SECTION 2: BE IT ORDAINED, that the Director of Public Works is authorized and directed to post suitable signs.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

SECTION 4: The City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
