Background:

Staff issued an Invitation to Bid for the Sewer Lining Project, PW-FY17-16, on October 27, 2016 in the Pioneer Press and the City website. Nineteen (19) firms registered via the City web site. At the public bid opening on November 8, 2016, five (5) bids were opened and read aloud.

The Sewer Lining Project is part of an annual program to rehabilitate aged and deteriorating sewer systems throughout the City. This statement of work includes quantities for 15,977 linear feet of sanitary and storm sewer lining in various sizes and lengths of cured-in-place pipe lining (CIPP).

Staff recommends that the contract be awarded to the lowest responsive and responsible bidder, Hoerr Construction, Inc. 1601-D West Luthy Drive, Peoria, Illinois.
