Re: Electricity Aggregation Program

Dear Participating Customer:

On March 20, 2012, the municipalities of Deerfield, Glencoe, Highland Park, Lake Bluff, Lake Forest, Northbrook, Park Ridge and Skokie, collectively known as the North Shore Electricity Aggregation Consortium ("Consortium"), approved referenda authorizing the purchase of bulk electricity from alternate suppliers other than ComEd. After an extensive bidding process, the Consortium selected MC Squared Energy Services, LLC ("mc²") to provide electricity supply services to member communities through May 2015.

Since the start of the program in June 2012, it is estimated that the average customer in the Consortium has saved over \$463* on electricity against current ComEd rates. Per the Power Supply Agreement terms, mc²'s electricity supply price is adjusted each June to reflect current market conditions. The new price effective with the June 2014 billing cycle will be 6.688 cents per kWh. The new price is projected to continue to provide savings against ComEd tariff rates.

The chart below highlights a detailed list of the estimated ComEd Rates compared to your new mc² price. Also note, ComEd no longer offers a discounted Residential Space Heat Rate. The price increase this period is due to the significant rise in the price of "Capacity" effective June 1, 2014. Capacity is the cost of generating electricity to meet demand during peak times. In the last two years, such capacity cost was lower and represented a smaller portion of the electricity price. However with an expected increase of more than 300%, it now is a substantial part of the electricity supply price.

Please note that ComEd will be making a change with respect to their methodology regarding allocation of network transmission costs to customers, and the revised approach will be applied to customers effective January 1, 2015. Any increase due to these changes will be directly passed through to Aggregation Members by a corresponding increase in the 6.688 cents per kWh Fixed Total Price following the effective date of the change. At this time, the exact amount of the expected increase is not known, but it is anticipated that Consortium customers will still realize a cost savings even after January 1, 2015.

In order to continue with the Consortium's Electricity Program, there is nothing you need to do. Your price will be automatically adjusted by mc² from 4.99 cents per kWh to 6.688 cents per kWh starting with your June billing cycle. Billing and service will remain the same: You will continue to receive a single bill from ComEd, and continue to be eligible for all ComEd payment options, including e-bill, automatic bill payment and budget billing. ComEd will also continue to be responsible for all wires, poles and emergencies, including outage restoration. In addition, as a valued customer, mc² has eliminated any early termination fees for participating customers which means that you can elect to return to ComEd without any additional cost.

Should you wish to voluntarily purchase 100% renewable energy through the Consortium's Green Power Program for an additional 0.14 cents per kWh (price adjusts from 6.688 cents per kWh to 6.828 cents per kWh through May 2015), simply Opt-In to the Green Power Program by visiting www.NorthShoreElectricityAggregation.com or by calling 1-888-808-7731. mc² will purchase Renewable Energy Certificates to cover 100% of your electricity supply requirements to support clean energy sources.

As always, no resident or eligible business located within a Consortium member community is obligated to purchase electricity from mc². If you wish to be excluded from this opportunity and return to ComEd or any other provider, please contact mc² directly at 1-888-808-7731.

* The savings estimate is based on the average savings of all Consortium members, between June 2012 and May 2014, as compared to their comparable ComEd Basic Electric Service Rate including the Purchased Electricity Supply Charge, Transmission Services Charge and Purchased Electricity Adjustment Charge. Savings estimated as of the end of January 2014.

** Savings estimates are based on a comparison to an estimated ComEd Basic Electric Service Rate starting June 2014 through May 2015, including the estimated Electricity Supply Charge and the estimated Transmission Services Charge and a Purchased Electricity Adjustment Charge estimated at \$0.5 cents/kWh. The estimated ComEd rate was derived by mc² by taking the current rate and adjusting it for the increase in capacity cost and projected energy supply costs for a single family account with average annual usage.
