**ORDINANCE**

**AMENDING ARTICLE 13, CHAPTER 16, SECTIONS 8 and 9**  
**and ARTICLE 13, CHAPTER 15, SECTION 1**

**SECTION 1:** BE IT ORDAINED, by the City Council of the City of Park Ridge that Article 13, entitled “Traffic,” Chapter 16, entitled, “Parking Meters and Metered Parking, Section 8 entitled, “Zones Designated,” of the Municipal Code of the City of Park Ridge is hereby amended by adding:

**13-16-8                    ZONES DESIGNATED**

**PARKING LOTS**

**SECTION 2:** BE IT ORDAINED, by the City Council of the City of Park Ridge that Article 13, entitled “Traffic,” Chapter 16, entitled, “Parking Meters and Metered Parking, Section 9 entitled, “Handicapped Parking Spaces” of the Municipal Code of the City of Park Ridge is hereby amended by adding:

**13-16-9                    HANDICAPPED PARKING SPACES**

**PARKING LOTS**

Dee Road Lot – West Side of Dee Road	6

**SECTION 3:** BE IT ORDAINED, by the City Council of the City of Park Ridge that Article 13, entitled “Traffic,” Chapter 15, entitled, “Limited Time Parking Areas”, Section 1 entitled, “Fifteen minute Loading Zone” of the Municipal Code of the City of Park Ridge is hereby amended by adding:

**13-15-1                    FIFTEEN MINUTE LOADING ZONE**

**PARKING LOTS**

<u>Parking Lots</u>	<u>No. of Spaces</u>
Dee Road Lot – West Side of Dee Road	3

**SECTION 4:** BE IT FURTHER ORDAINED that the Director of Public Works is authorized and directed to post suitable signs.

**SECTION 5:** BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

**SECTION 6:** BE IT FURTHER ORDAINED that the City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
