Background:

Staff issued an Invitation to Bid for Cleaning and Custodial Services, PW-FY18-06, on June 8, 2017 in the Pioneer Press. Eighteen (18) firms registered via the City web site. At the public bid opening on June 27, 2017, three (3) bids were opened and read aloud, one (1) was deemed non responsive.

This contract is for the following municipal facilities: City Hall, Service Center, Uptown Train Station, Dee Road Train Station, Police Annex, Fire Station 35 and Fire Station 36. The contract includes the following services: window washing, carpet cleaning, waxing of tile floors, evening vacuuming, refuse collection, dusting, cleaning of floors and washrooms, and additional cleaning as needed.

Reference checks were performed and were positive. Staff recommends that the contract be awarded to the lowest responsive and responsible bidder, Eco Clean Maintenance, Inc. Elmhurst, Illinois.

This item was presented as an Action Item at the Committee of the Whole on July 10, 2017, at which time the Committee approved the motion on a voice vote of 7/0.
