Background:

In May 2016, the Council approved a contract for Emergency Watermain and Sewer Work Services, PW-FY17-01, with DiMeo Brothers, Inc. The contract term was for one (1) year and may be extended for up to two (2) one (1) year periods; the overall term period is not to exceed three (3) years. The contract allows for annual unit increases based on the CPI, with a maximum of 3%.

Staff has received correspondence from DiMeo Brothers, Inc. regarding a one (1) year contract extension, a copy of which is attached, with no rate increase. Staff recommends that the City avail itself of this extension.

This item was presented as an Action Item at the Committee of the Whole on June 12, 2017, at which time the Committee approved the motion on a roll call vote of 7/0.
