Background:

On March 7, 2016 the City Council approved revising parking prohibitions on Main Street, from midnight to 2 a.m. During the approval process, staff was asked to revise the same restriction on Prospect Avenue, from Northwest Highway to Summit, in order to accommodate the restaurants in this area as well.

As on Main Street, the reason for the midnight to 6 a.m. parking restrictions in the business area is to allow for Public Works crews to get into the area for street sweeping and for snow removal operations. As such, in the interest of being business friendly, Public Works will be able to work around a revision to make the parking restriction begin at 2 a.m.

This item was presented as an Action Item at the Committee of the Whole on March 16, 2016, at which time the Committee approved the motion on a voice vote of 6/0.

ORDINANCE

**OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE
AMENDING ARTICLE 13, CHAPTER 12, SECTION 5
OF THE CITY OF PARK RIDGE MUNICIPAL CODE**

SECTION 1: BE IT ORDAINED, by the City Council of the City of Park Ridge, that Article 13, "Traffic," Chapter 12, "Restricted Parking," Section 5, "Parking Prohibited Within Certain Hours, Tow Zone," is hereby amended as follows language:

Street	Side of Street	From	To	Restricted Hours
Prospect	Both sides	Garden	Northwest	12 Midnight to 6 a.m.
Prospect	Both sides	Garden	Main	12 Midnight to 6 a.m.
Prospect	Both sides	Summit	Northwest Highway	2 a.m. to 6 a.m.

SECTION 2: The Director of Public Works is authorized and directed to remove any signs posted on said roadways setting forth said restrictions.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

SECTION 4: The City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
